- 1. Meeting called to order at 7:04 by Chairman Rusty Strauss**
  
- 2. Present: Rusty Strauss, Stock Illoway, Dave Jarvie, Frank Giardina, John Schott, George Irwin**

- 3. Stock moved and Frank seconded the approval of the minutes of March 15, 2011**
  
- 4. Updates:**
  - A) Coccia property - Wait until fall to visit the process of moving forward**
  - B) Meyer - Mr. Meyer has a serious case of Lyme disease - He has put some property up for sale. He understands the process involved and will keep us in mind with respect to his properties.**
  - C) Orr - Our recommendations will be presented to the Supervisors for consideration at their May meeting**
  - D) Kolb - He will be meeting with Stock in two weeks - He is very interested in how the Latshaw deal proceeded.**
  - E) Discussions with Ben Campbell - Preliminary discussions about a bond issue but not in depth.**

**10. Rusty opened up a discussion of the "Maps" that have been prepared. Dave suggested that we highlight the properties that we have preserved.**

**Protection of the Stoney Run could be a goal of our committee. Stock suggested that we open up talks with Marcus first, followed up with moving forward with Benyo. John will talk to Hunsberger about his property**

**Rusty will determine where the Cutler property is as well as where the Krauss properties are and their status.**

**With respect to the maps, it was discussed where both the open space and homeowners open space was in the Kimberton Meadows subdivision.**

**The Hares Hill development is approved for development but is on hold.**

**It was discussed we should use these maps and overlays for defining the trail system.**

**A brief discussion on agricultural security areas was held. Properties do not have to be contiguous**
